Terms and conditions storage service

- Notify the right or purpose of using the storage service at least 3 days in advance.
- You can bring your private key to lock your room. (In case of using self-storage rental service only)
- Item type agreement that excludes items or does not store service.
- All illegal items, all types of drugs, firearms, ammunition, sulfur gunpowder.
- Dangerous chemicals, liquid chemicals
- All kinds of items that require temperature determination
- Valuable items or treasures such as art, money, gold
- expired objects, food, or strongly smelly objects
- Flammable materials, articles, goods intended for environmental conditions and temperature
- Batteries, all kinds of electrical storage devices
- animals or living things

- The company will not immediately return the place to you at that time.
- In case you want the company to bring it back the company will charge part of the cost of the car, the employee's cost to bring the goods back.
- The company reserves the right not to be responsible for items that violate the conditions of deposit in all cases.
- · Monthly deposit payment agreement
- Pay on time every day that items are brought in on the first day.
- Payment over the due date must not exceed 3 days, not more than 2 times
- If the payment is overdue, the company reserves the right to adjust the payment of the daily rental price.
- If the store has not been paid in full for 7 days, the company reserves the right to release the key to reposition the unpaid items at another point without any prior notice.
- If the warehouse rent is not paid within 60 days, all items will be sold at auction without prior notice. and will not be responsible for your belongings in any case
- Good move storage insurance is only insured against fire of large warehouses. The guarantee of items will end only when the case that you use the Good move service, moving items which have been checked before entering the store and signed off insurance only after the incoming case work has been completed, and without which the company will not have Guarantee against damage to your items after they have been imported into the store in any event or circumstance.
